Currently, there is no structure on the property. Previously, this location had a structure and was used as Rusk Nursing Home. The nursing home was demolished in 2020.

The property under consideration is addressed as <u>272 N. Main St. Rusk</u>, <u>TX 75785</u>, and located 487 feet north of E. 7th Street at N. Main St. and 321 feet South of E. Hill at N. Main St. Currently, there is no structure on the property.
